Happy Fall!

It's been quite the busy Fall following on the heels of a busy – and momentous – Summer!

In August, RHA hosted the groundbreaking for our new Federal Street and Scattered Sites affordable housing development project. We had a packed house followed by many congratulatory remarks from state representatives and our local community partners.

This project will create 18 new homes at the currently blighted RHA property on Federal Street. This includes two low-rise, multi-family buildings and a single-family home, plus free Wi-Fi, an electric vehicle charging station, and a playground.

The remaining 24 sites will create or rehabilitate 53 energy-efficient homes. Located primarily within the Beechwood neighborhood, all housing combined will include 26 two-bedroom, 22 three-bedroom, and five four-bedroom units. Rehabilitated homes will include new high-efficiency boilers, improved ventilation, enhanced insulation, and window replacements. Nine apartments will have supportive services for individuals experiencing homelessness. This is the first of many projects to help increase, preserve, and diversify housing options and revitalize neighborhoods.



We are also excited to be moving forward with our next public housing preservation project at Parliament Arms and Fairfield Village, located at 2120 St. Paul Street and 35 Luther Circle. These locations currently house 96 multifamily apartments, none of which are accessible. At Parliament Arms, the current eight-unit building at the rear of the site will be demolished and replaced with a 15-unit, fully-accessible elevator building complete with an accessible community room. At Fairfield Village, three units will receive additions and alterations to be made ADA-accessible. Once completed, Parliament-Fairfield will have 103 total residences. In addition to accessibility, the rehabilitation will

also improve marketability, energy efficiency, and tenant quality of life. We will continue to share the progress on this project with you during the coming months.

Don't Struggle with High Internet Fees!

RHA residents can qualify for a \$30/month discount on internet services. Applying is easy:

Have your social security number available, then call (877) 384-2575. (Be sure to ask about a one-time discount of up to \$100 for purchase of a laptop, desktop computer, or tablet through a participating provider.)

Once you are approved, contact your Internet Service Provider and ask them to apply the discount to your monthly bill. That's it!



Homeownership

Instead of using your voucher subsidy to help with rent, the RHA Homeownership Voucher Program provides the opportunity for existing voucher holders to use their voucher subsidy to purchase a home and pay for monthly homeownership expenses. We currently have four families with pending home closings and 11 who closed this year throughout Monroe County. Congratulations!

Family Self-Sufficiency Program Update

Our Family Self-Sufficiency (FSS) Program is a voluntary employment and savings incentive program. We currently have 184 participants enrolled in the program. Recent achievements include two recent graduates who came to the program with employment goals. One who graduated after eight years now is entitled to more than \$14,000 in escrow savings. The second program participant graduated after six years and now is entitled to receive nearly \$9,000 in escrow savings.

Continued Partnership

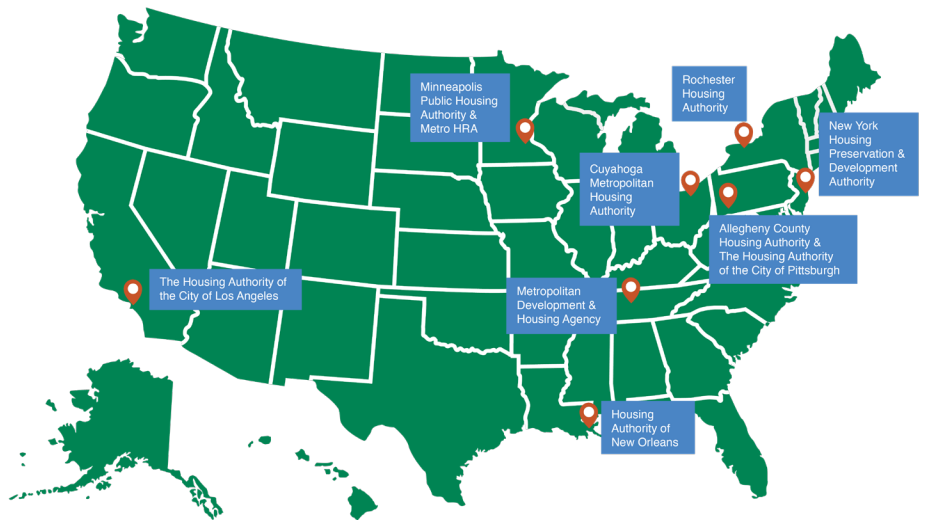
We continue our partnership with Trillium's COVID testing/Primary Care services.

New HUD Regulatory Requirement

A regulatory requirement from the U.S. Department of Housing and Urban Development (HUD) requires that RHA must inform its public housing residents of the “over-income” mandate. For those families whose income currently exceeds the applicable over-income limit, they have two years from the date of the over-income determination to find new housing, with an additional six-month window for a family to complete its move out of public housing. RHA’s Resident Services department will assist in providing additional opportunities and resources for these families, some of whom also may have the ability to become successful homeowners.

Strong Families

RHA held a series of Strong Family events at seven of our Public Housing apartment complexes throughout the summer, partnering with Rochester Empowerment Center, Anthony Jordan Health Center, CASH, City of Rochester, the Home Ownership program, and Rec on The Move.



Senior Summer Gathering

On August 4, 130 residents attended this year’s senior summer gathering. Attendees had the opportunity to get health screenings by Common Ground Health and to learn about wills and estate planning from LawNY and health care benefits from Fidelis Care and Lifetime Financial Group. Community Choice Demonstration

RHA is one of nine Public Housing Authorities selected to join HUD’s Community Choice Demonstration (CCD). This six-year study is designed to increase participation from voucher families with children under 17 to receive better access to low-poverty neighborhoods and other opportunity areas with high-performing schools and other strong community resources.
