
#### ITEM AD 1-1 Refer to Drawing L2.0 - "SIDEWALK IMPROVEMENT PLANS"

**Amend** new entrance drive sidewalk location to be installed approximately one (1) foot from edge of existing entrance drive. New asphalt patching to match existing shall be laid between existing entrance drive new sidewalk as shown on attached drawing AD-L1, issued with this addendum.

#### ITEM AD 1-2 Refer to Drawing L3.0 - "SITE DETAIL"

Add detail as shown on attached drawing AD-L2, issued with this addendum. Existing scalloped landscape edging to be removed in its entirety. Existing grade to begin approximately two (2) inches down from top of sidewalk and return to existing grade approximately one (1) foot away from edge of sidewalk. Landscaping changes to occur in all landscaping beds and along all sidewalks (both those being replaced and those to remain.)


