#### **Questions Asked at Pre-Bid Walk Through:**


- Q: Is GAF Seal-a-Ridge Ridge Cap acceptable?
   A: Undetermined at this time. Contractors are permitted to submit"or equal" products for review and approval during the project.
- Q: Is RHINO synthetic underlayment acceptable? (Their website states that it meets ASTM D226 Standards)


A: Undetermined at this time. Contractors are permitted to submit"or equal" products for review and approval during the project.

- 3. Q: Is GEOCELL 2300 Tripolymer sealant acceptable?
  A: Undetermined at this time. Contractors are permitted to submit"or equal" products for review and approval during the project.
- 4. Q: Are we painting the entire chimney?
  - A: Yes.
- 5. Q: Is it necessary to leave a full gallon of chimney paint behind?
  - A: Yes.
- 6. Q: Does the storm collar and flange for the furnace exhaust flue pipes have to be replaced?
  - **A:** Yes; everything that makes the new roof assembly water tight (flashing, boots, collars, etc.) above the roof framing needs to be replaced.

- 7. **Q:** The specifications do not state anything about the exhaust flue pipe caps. Are they to be replaced or reused? In my experience, it is often not possible to reuse the caps because of deterioration.
  - A: All existing caps shall be replaced as required to install new collars.
- 8. **Q:** In the Side Eave Detail, it shows the exterior grade sheeting almost flush with the fascia board. This could pose a problem as the metal depicted in the drawing will be in the gutter on one end of the roof and not the other when the gutters are pitched properly. Should the sheeting be extended 3/4 inch past the fascia board and use F5 drip metal instead of C51/2?
  - A: Refer to AD-A2 for a revised detail.
- Q: This question may not pertain to you, but maybe you can help clarify it. I noticed on page 1 or 9 of the labor rates section the "Construction Type" is stated as Residential. Is this correct?
   A: Yes.




