# Item AD 1-1 Refer to Drawing C2.0- "SITE IMPROVEMENT PLAN"

- **Revise** Site Improvement Note #13 to read "Contractor to provide seeding and mulching in all disturbed areas, and to ensure areas are watered and established."
- **Remove** note #8 "Provide Landscaping". Landscaping will be removed from project scope.
- **Replace** existing Callout #8 with #13 "Contractor to provide seeding and mulching in all disturbed areas, and to ensure areas are watered and established."
- **Revise** no parking space striping and sign to be to the right of the accessible parking space.

## Item AD 1-3 Refer to Drawing C3.0 - "SITE UTILITY PLAN"

 Revise Site Utility Note #1 to read – "Provide private stormwater catchbasin with stub per detail 2/C3.0. Contractor is to reconnect existing invert (N- 489.72) and to provide a PVC Backwater Valve to match existing pipe size."

# QUESTION #1 – Are there WBE/MBE goals to be met?

• While the RHA does not have specific MBE/WBE goals for this contract, RHA encourages participation by, and the inclusion of, MBE/WBE and Section 3 firms to the greatest extent feasible.

#### QUESTION #2 - What permits are the contractor required to get?

• Contractor is required to obtain City Right-of-way Permit, Plumbing Permit, and Parking Lot Permit.

• The completion date will be 90 days from contract signing.

#### QUESTION #4 – Who is responsible for compaction testing?
