Jennifer Leonard, President, and CEO, of the Rochester Area Community Foundation. She presented their leadership in the effort to close educational opportunity gaps, address poverty, promote racial equality, and to support the arts.

Todd Baxter is the Executive Director of the Veterans Outreach Center. He presented the outreach efforts of his organization to a large number of transitioning veterans. With the military, down-sizing, there is a large demand for housing. His vision is in line with Michelle Obama's Veterans initiative.

Jean Carroll, President, and CEO, and Mariam Moore-Burt, Vice President of Racial Equity Initiative, present on the resource in our community that assists women and girls who are faced with personal crises including homelessness and teen pregnancy. They work hard to dispel stereotypes and promote racial justice. Their goal is to empower women to regain control of their lives and to get on the path to a healthy successful future.

- a. Executive Director John Hill presented his director's report on the following topics:
 - 1. John Hill updated the Board on the rollout of the Strategic Plan Goal Tracker. The Crisis Communication Plan will include himself and the Executive Team. Rochester Housing Authority (RHA) is still waiting on the HAP contract Waiver update from HUD. The Moving to Work (MTW); Notice of Funds Availability (NOFA) has not been posted yet. The Housing Choice Voucher Administrative fee has been at all time low. The Ross for Education Grants, RHA received the notification from HUD on in January.

Ms. Martin presented an update on the implementation of RHA's Strategic Plan Goal III "Support our Employees to Enhance an Organizational Culture of Excellence. Ms. Martin provided the board with the training sessions. Commissioners Rivera inquiries about the Civil Service examine for a bilingual Managerial title. Ms. Martin will follow up with Commissioners Rivera. She will report at one of the sub-committee meetings with her finding.

Ms. Herriott reported on her goals from 2016. She reported on her ongoing training and receipt of certifications. She has successfully completed the Moral and Inclusion Cultural Committee. The committee conducted a Cultural Pot Luck Luncheon, which was very successful.

6. Finance Report

Director of Operations, Foti reported RHA's COCC, Public Housing, and Section 8 financials. COCC has an increase based on Management Fees, Rent and Section 8. COCC, Public Housing and Section 8 are doing well.

7. **Public Housing Report**

Public Housing Director, Whitney reported to the Board; there was a total of 31 move outs for this period: 15 Voluntary, 0 Termination, 2 Death, 6 Evictions, 6 Transfers, 1 Health, and 1 No Notice. Public Housing should see a significate rent increase this month as well as next month. Our arrears will decrease significantly.

Leasing Operations Report (Section 8)

Voucher Utilization Report: Director Harris presented the Section 8 Committee report. She also presented the Voucher Utilization report. The Public Hearing was held on Thursday, January 5, 2017, at RHA. The Voucher Utilization Rate for November was 102%; utilizing 9,262 vouchers.

8. Family Self-Sufficiency Report

Supervisor for Family Self-Sufficiency (FSS), Melissa Berrien presented an overview of Resident Services. Mr. Smith and Mr. Sayed successfully completed the program.

RHA had seven new hires that are self-certified as Section 3. We have one New Section 3 Business, CNS Construction.

9. Planning Committee Report

Deputy Executive Director, Shawn Burr reported on Garson Ave Ribbon Cutting Press Conference, which was a success. He provided the status of Eiffel Place, Shirly Street, Waring Road, and Federal Street. Projects that are complete; Bartlett-Reynolds, Johnathan Child, and University Tower.

10. Commissioners' Report

Commissioner Page attended a PHADA Conference; he presented how the 'Trump Administration and 115th Congress Must Enact Major Changes in Public Housing." Low funding threatens Homes of millions of low-income persons. RHA is going in the right direction, and we are head of the curve. Changing the face of Public Housing is the way to go, and Garson Ave is an example of the Board vision for Public Housings.

Commissioner Page, Commissioner Lee, Commissioner Otis, Commissioner Patterson, Commissioner Valencia, and Commissioners Rivera voted <u>yes</u>. The motion was <u>passed</u>.

Commissioner Otis <u>moved</u>, and Commissioner Lee <u>seconded</u> the motion to approve this request. Commissioner Page, Commissioner Lee, Commissioner Otis, Commissioner Patterson, Commissioner Valencia, and Commissioners Rivera voted <u>yes</u>. The motion was <u>passed</u>.
