ROCHESTER HOUSING CHARITIES REVEALS NEW AFFORDABLE HOUSING PROJECT

\$500,000 Investment to Create Quality Homes for Working Families

ROCHESTER, N.Y., May 25, 2018 – Today, Rochester Housing Charities (RHC) cut the ribbon at 16 Diamond Place, a new quality, affordable home in the Beechwood neighborhood. This is the first of four homes to be built on this street, after the removal of the current vacant properties currently existing there. This four-home project is a \$500,000 investment funded through Rochester Housing Charities to support the mission of providing quality, affordable housing and services to the elderly and disabled families including young children.

"We built these beautiful new homes with the goal of raising the standard of living for working families and to create stronger communities around them that can be successful long-term," said Reece McKenzie, RHC Board Chairman. "These four homes are really more than that, they're the launching pad to a positive domino effect across the Beechwood community."

In 2016, the City of Rochester put out an RFP to develop these vacant parcels of land, which had been vacant for nearly five years after the abandoned properties on those sites were demolished. In 2017, Rochester Housing Charities was awarded the RFP and began the process of transforming Diamond Place.

"Affordable and safe homes are a fundamental building block in helping families and communities reach their full potential," Mayor Lovely A. Warren said. "These new homes, built by Rochester Housing Charities, represent an important investment in this neighborhood and in its people, contributing to more jobs, safer and more vibrant neighborhoods and better educational opportunities for all."

All four properties were designed by Pardy Partnership Architects. Construction on 16 Diamond Place was completed this week, with the additional properties scheduled for completion before the end of this year.

- <u>16 Diamond Place</u>: Model A, 912 sq. ft, one story, two-bedroom, one bath, built on a 40' lot
- <u>3 Diamond Place</u>: Model B, 840 sq. ft., two-story, two-bedroom, one and a half bath, to be built on a 33' lot
- <u>15 Diamond Place & 12 Diamond Place:</u> 882 sq. ft, Model C, two-story, two-bedroom, one and a half bath, to be built on a 40' lot

"This is a meaningful milestone for the Beechwood Neighborhood, which is seeing its first new construction build since 2002," said George Moses and John Page, Chair and Vice Chair of Rochester Housing Authority. "We made a promise to this community to finish this challenge street and make it a true neighborhood, full of homes and not empty abandoned lots, and I'm excited to stand here today with all those involved in helping to make that promise a reality."

The first homeowner to move into the new development is Lorretta Cross, a well-known Beechwood resident and community advocate. To welcome Loretta to her new home, RHC dedicated Pee-Wee's Garden at the property in honor of her two-year-old grandson, who was tragically lost when hit by a car while chasing a ball in 2016.

I look forward to continued investment towards affordable and quality housing across the City of Rochester."
