Chair Moses called the October's RHA Regular Board Meeting to order at 12:00 PM. He noted for the record that notice of this meeting was posted as required by law and there was a quorum present.

1. Open Forum – Public Comments

Bill Slocum provided public comments about RHA's Health Care options.

2. <u>Elected Commissioners Oath</u>

Chairman Moses swore in Commissioner Patterson and Commissioner Otis.

3. Approval of Minutes: September Regular Board Meeting

Commissioner Rivera moved, and Commissioner Otis <u>seconded</u> the motion to approve the minutes for the September 2016 Regular Board Meeting. Commissioner Lee, Commissioner Patterson, Commissioner Page, Commissioner Valencia, Commissioners Otis, and Commissioner Rivera voted <u>yes</u>. The motion was <u>passed</u>.

4. <u>Director's Report and Board Approval Requests</u>

- a. Executive Director John Hill presented his director's report on the following topics:
 - 1. Mr. Hill presented on the Move to Work (MTW) program and how RHA can benefit from this program. Moving to Work (MTW) is a demonstration program for public housing authorities (PHAs) that provide them the opportunity to design and test innovative, locally-designed strategies that use Federal dollars more efficiently. MTW also help residents find employment and become self-sufficient and increase housing choices for low-income families. MTW gives PHAs exemptions from many existing public housing and voucher rules and more flexibility with how they use their Federal funds. MTW PHAs are expected to use the opportunities presented by MTW to inform HUD about ways to better address local community needs.

iv. Employee Medical Insurance (Active Non-Union Employees & Retirees < 65 yrs.)

– HR

Commissioner Valencia <u>moved</u>, and Commissioner Page <u>seconded</u> the motion to approve this request. Commissioner Lee, Commissioner Patterson, Commissioner Page, Commissioner Valencia, Commissioner Otis and Commissioner Rivera voted <u>yes</u>. The motion was passed.

v. Purchase Order for HAS/FSA/HAS Accounts – HR

Commissioner Valencia <u>moved</u>, and Commissioner Page <u>seconded</u> the motion to approve this request. Commissioner Lee, Commissioner Patterson, Commissioner Page, Commissioner Valencia, Commissioner Otis and Commissioner Rivera voted <u>yes</u>. The motion was passed.

vi. Social Media Policy - HR

Commissioner Otis <u>moved</u>, and Commissioner Patterson <u>seconded</u> the motion to Table this request. Commissioner Lee, Commissioner Valencia, Commissioner Patterson, Commissioner Rivera, Commissioner Otis, and Commissioner Page voted <u>yes</u>. The motion was <u>passed</u>.

viii. 2016-2017 Snow Plowing – Public Housing

Commissioner Lee <u>moved</u>, and Commissioner Otis <u>seconded</u> the motion to approve this request. Commissioner Valencia, Commissioner Patterson, Commissioner Lee, Commissioner Rivera, Commissioner Otis, and Commissioner Page voted <u>yes</u>. The motion was <u>passed</u>.

ix. Resolution RAD - Legal

Commissioner Valencia <u>moved</u>, and Commissioner Rivera <u>seconded</u> the motion to approve this request. Commissioner Valencia, Commissioner Patterson, Commissioner Lee, Commissioner Rivera, Commissioner Otis, and Commissioner Page voted <u>yes</u>. The motion was <u>passed</u>.

5. Executive Personnel Administrator Report

Ms. Martin presented an update from her 100-day plan of the first 60 days; September 16th through October 16th, 2016. The areas include supporting Rochester Housing Authority (RHA) employees to enhance an organizational culture of excellence, to improve internal and external communication, and to address other Human Resource (HR) matters.

6. Compliance, Diversity and Inclusion Officer Report

Ms. Herriott reported her updated 90 Day Plan; she is reviewing our policies, the roles of staff, and RHA's products and services.

7. Finance Report

Director of Operations, Foti reported on the COCC Public Housing, and HCV budgets. RHA is very stable.

8. Public Housing Report

Public Housing Director, Whitney reported to the Board; there was a total of 22 move outs for this period: 7 Voluntary, 1 Termination, 1 Death, 4 Evictions, 3 transfers, 1 Health, 5 Section 8. Director Whitney also presented the monthly security report for public housing. Studio apartments are still at a high vacancy.

9. Housing Operations Report (Section 8)

Voucher Utilization Report: Director Harris presented the Section 8 Committee report. She also presented the Voucher Utilization report. The Voucher Utilization Rate for August was 99.87%, utilizing 9,186 vouchers which are up from August. RHA staff is working hard to maximize the utilization rate.

10. Family Self-Sufficiency Report

Supervisor for Family Self-Sufficiency (FSS), Melissa Berrien presented an overview of Resident Services. Ms. Parsons and Mr. Malik have successfully completed the program. There are three new hires in October who are self-certified as Section 3 eligible.

11. Planning Committee Report

Architect, Linda Stango presented an overview of projects in progress, projects completed, service contracts, and projects out for bid. Some of the current projects that are in progress include Johnathan Child, 54-66 Garson Ave, 675 West Main Street, and University Tower.

12. Commissioners' Report

Commissioner Moses and Paul Foti met with Richard Cordray, who is the director of Consumer Financial Protection Bureau. He fined Wells Fargo for egregious acts, which are normal banking practice. He would like the Consumer Financial Protection Bureau to direct these fines back to the folks that are affected.

Chair Moses into Executive Session, Commissioner Lee <u>moved</u>, Commissioner Rivera <u>seconded</u> to go into Executive Session for a Legal and a Personnel matter at 1:23 PM. Commissioner Rivera, Commissioner Lee, Commissioner Patterson, Commissioner Page, Commissioner Otis, and Commissioner Valencia voted <u>yes</u>. The motion was passed.

Commissioner Rivera <u>moved</u>, and Commissioner Lee <u>seconded</u> to end the Executive Session. Commissioner Lee, Commissioner Valencia, Commissioner Rivera, Commissioner Page, Commissioner Otis, and Commissioner Patterson voted <u>yes</u>. The Executive Session ended at 3:08 PM. The motion was <u>passed</u>.

13. November Regular Board Meeting

The November Regular Meeting of the Rochester Housing Authority Board is scheduled for Wednesday, November 16, 2016, at 12:00 noon in the Board Room (Room #121) at 675 West Main Street.

There being no further Regular Meeting Business to come before the Board, Commissioner Rivera <u>moved</u> that the Regular Meeting be adjourned. Commissioner Lee <u>seconded</u> the motion, Commissioner Lee, Commissioner Patterson, Commissioner Otis, Commissioner Rivera, Commissioner Page, and Commissioner Valencia voted <u>yes.</u> Chair Moses <u>adjourned</u> the Regular Board Meeting at 3:09 PM.
