Chair Moses called the October Rochester Housing Authority (RHA) Regular Board Meeting to order at 12:00 PM. He noted for the record that notice of this meeting was posted as required by law and there is a quorum present.

# 1. **Open Forum – Public Comments**

Dorothy Tucker, JWRC President, lives at Ridge Hudson Tower; she commented on the changes to the Public Housing Staff. She is very unhappy with the changes; the residents currently don't feel safe, they are complaining about the illegal activities that are going on since the change. It would be great to receive a notice to let the residents know about the change in Hudson and Ridge's staff. The previous staff knew the resident's needs. She believes this change will affect their elderly population and with the new staff, Hudson and Ridge are suffering. The residents are asking RHA to bring back the old staff to Hudson Ridge. Ms. Tucker submitted wiring request to have voted for Resident Commissioners Board Members to be extended. JWRC declined the Laundry Service and is requesting additional meetings.

Katherine Warren, Secretary Resident Council, Facilitator for Tenants on Patrol is not happy with the change of RHA staff to Hudson Ridge Tower. The new staff needs to engage with the residents, and they are not doing that. She states there are prostitutes and drug dealers at her site. She is asking for emergency lighting immediately. She has lived in Hudson and Ridge a long time and since the new staff has been there nothing is the same, and they don't feel safe. She is also asking the old staff to return to Hudson and Ridge.

Hester Reeves from Seneca Towers concern is when there is an emergency; she felt the APC Security didn't respond to her needs promptly, it was two hours before someone showed up. She is not happy with the new staff, she tried to contact one of the staff from RHA, and it took hours for that person to respond. She is not used to this type of service from RHA. She is asking for the previous staff to return to Hudson and Ridge.

Hurricane evacuees from Puerto Rico and the Virgin Islands, On October 6, 2017, PHA's received an email form HUD Buffalo Field Office addressing the issue. However, it states HUD will issue an official guidance and Waiver in the upcoming weeks.

On Monday, October 16, 2017, about 15 agencies met at IBERO to discuss ways to assist the families who may be relocating to Rochester. This Meeting was chaired by Hilda R. Escher of IBERO. There will be

Ms. Herriott reported that RHA remains a part of the Structural Racism Initiative. CDI continues to work with Rochester City School District on several community inclusion initiatives.

Mr. Foti states that the Budget vs. Actual, are doing well. Public Housing and Section 8 Budget is on target. He will provide additional information after the books are closed.

Public Housing Director, Whitney reported to the Board; rent collection is going well. There was a total of 2 move outs for this period: 1 Non- Payment, and 1 Eviction. The vacancy rate is around 2.90%.

**Voucher Utilization Report:** Director Harris presented the Section 8 Committee report. Utilization rate as of August 2017, was 94.72%, utilizing 9,069 vouchers. Ms. Harris reported on the HQS this month, and inspection is going well.

# 9. Family Self-Sufficiency Report

Melissa Berrien

Supervisor Melissa Berrien for Family Self-Sufficiency (FSS) presented that Ms. Madera Torres has received her Associates in Applied Science from Bryant Stratton with a Major in Criminal Justice. FSS enrolled six next participants in the FSS Program; two reported new full-time employment, and two reported attend college at Monroe Community College (MCC). In 2016, 73% of RHA new hires were Section 3.

# 10. Planning Committee Report

Deputy Executive Director, Shawn Burr reported on current projects that are in the construction stage, Kennedy Tower window replacement, Lena Gannt Roof, and siding replacement Phase II. Seneca Manor Townhouses is 99% completed.

#### 11. Commissioners' Report

Commissioner Rivera would like to start an Adhoc Committee around NYS Prosperity Initiative Commissioner Rivera <u>moved</u>, and Commissioner Page <u>seconded</u> the motion to approve this motion. Commissioner Patterson, Commissioner Page, Commissioner Lee, Commissioner Otis, Commissioner Edwards, and Commissioner River voted <u>yes</u>. The motion was <u>passed</u>.

Commissioner Lee would like extra security and to ensure our residents are living in safe units. He will follow up with the Public Housing Director.

Commissioner Moses presented that he was able to take the Low Income Take Credit Course. He passed the examine.

Commissioner Page <u>moved</u>, and Commissioner Patterson <u>seconded</u> the motion to approve Resolution 09.27.17.01. Commissioner Page, Commissioner Lee, Commissioner Otis, and Commissioners Patterson voted <u>yes</u>. The motion was <u>passed</u>.
